2. In pursuance of the UN Security Council Resolution No. (1970) 2011 and its subsequent resolutions, SROs are issued by the Government of Pakistan whenever the Consolidated List maintained by the 1970 Sanctions Committee is updated.
3. The Consolidated United Nations Security Council List is also updated following all changes made to the Libya Sanctions List. An updated version of the Consolidate List is available on the UN Security Council website.
4. All concerned are also requested to regularly access the Libya Sanctions List to ensure compliance with the measures mentioned above in line with the UNSC resolutions.

**ORDER**

S.R.O. 528/2021- WHEREAS the United Nations Security Council vide its resolutions nos. 1970 (2011), 1973 (2011), 2009 (2011), 2016 (2011), 2017 (2011), 2040 (2012), 2095 (2013), 2144 (2014), 2146 (2014), 2174 (2014), 2213 (2015), 2214 (2015), 2278 (2016), 2292 (2016), 2357(2017) and 2362 (2017) concerning Libya has directed to apply arms embargo against Libya, and travel ban, assets freeze and other business restrictions, and measures in relation to attempts to illicitly export petroleum, including crude oil and refined petroleum products, against certain individuals and entities under Chapter VII of the United Nations Charter;

AND WHEREAS the United Nations (Security Council) Act, 1948 (XIV of 1948) enjoins upon the Federal Government to apply certain measures for giving effect to the decisions of the United Nations Security Council;

NOW, THEREFORE, in exercise of the powers conferred by Section 2 of the United Nations (Security Council) Act, 1948 (XIV of 1948), the Federal Government is pleased to order that the individuals listed in the Annexure to this order reflecting the amendments made by the Libya Sanctions Committee of the United Nations Security Council shall stand subjected to assets freeze, travel ban and other measures relating to attempts to illicitly export petroleum, including crude oil and refined petroleum products, in accordance with the relevant paragraphs of the aforementioned United Nations Security Council resolutions with immediate effect.


